## **Pepe Weed (PWEED) Token Sale Terms & Conditions**

The Terms and Conditions (the "T&C" or "Terms") apply to the buyer of the PWEED Utility Token (hereinafter "PWEED") and future user of the Pepe-Weed platform and constitute an agreement between Pepe-Weed Team. and you. Please read these terms carefully before participating in the token pre-sale and sale. The T&C outline your obligations and legal rights, including limitations of liability. If you do not agree to these terms, do not participate in the PWEED token sale.

By purchasing PWEED during the token pre-sale or crowdsale period, you agree to these T&C and all incorporated terms. Your PWEED purchase is subject to this agreement. You may not participate if you are under 18 years old or reside in restricted areas as described below.

### **Applicability**

These T&C constitute the agreement between Pepe-Weed Team., a [jurisdiction] corporation, and you, the user, regarding purchase of PWEED tokens and use of Pepe-Weed platform services. By using our services, you agree to the latest T&C version, which may be modified at any time at our sole discretion.

### **Services**

1. PWEED aims to revolutionize the medicinal cannabis industry by seamlessly integrating blockchain technology to cultivate a healthier, more informed world.
2. Based on Solana, PWEED will be issued for services on the Pepe-Weed platform and as community rewards.
3. Verified KYC enables participation in the PWEED token sale.
4. PWEED does not represent shares, ownership, rights to revenue, governance rights or stake in Pepe-Weed. PWEED is a utility token for platform access and is final and non-refundable.
5. PWEED can be purchased during pre-sale and crowdsale from Pepe-Weed Team or potentially on exchanges after, per guidance.
6. No guarantees that PWEED will be listed or remain listed on any exchanges.
7. PWEED is not an investment product and holding it involves risks that it may lose value or become worthless. You represent understanding these risks.
8. Pepe-Weed may manage funds received to mitigate volatility risks, at its sole discretion.
9. PWEED is an unregulated utility token. Pepe-Weed Team. does not provide regulated financial services and PWEED should not be considered a financial product.

### **Token Distribution**

Token distribution is not an equity or debt public offering and does not require securities registration. You may contribute accepted digital assets or fiat currency and receive PWEED in exchange. Pepe-Weed Team. reserves the right to amend accepted payment methods. All PWEED acquisitions will be publicly visible on the Solana blockchain.

### **Knowledge Required**

1. You acknowledge reviewing these T&C and understanding the costs, benefits and risks of

acquiring PWEED.

2. You have significant cryptocurrency, blockchain and associated risk experience to acquire PWEED.

3. Pepe-Weed is not liable for any loss of PWEED or inability to access it due to your actions.

4. You agree PWEED may require updates or modifications that you must follow to retain functionality.

## **Risks**

Acquiring and using PWEED involves many risks, including but not limited to:

1. **Development Failure or Abortion:** Pepe-Weed may not be able to fully launch, develop and operate its platform and community as intended. Carefully consider the costs, benefits and risks before acquiring PWEED.

  - f) Are not acting for the purpose of speculative investment
  - g) Reside in a jurisdiction allowing Pepe-Weed's token sale without local authorization
